GENERAL CANCELLATION POLICY

Withdrawal and Reimbursement

Any request for withdrawal and reimbursement must be in written form. You may be reimbursed in a case of force majeure when the registration is cancelled within 30 days before the starting date of the course or in the case of an anticipated departure. In that case, the school may consider a 50% reimbursement only if supporting documents are presented and if the request has been approved by STRALANG. Professional motives and obligations are not considered as cases of force majeure.

After the final registration, if the student began to attend classes, no refund can be made regardless the reason of the cancellation.

The school reserves itself the right to modify or cancel any course at any moment. If the school finds itself forced to cancel a course, the school will do its best to offer an alternative course to the student.

Private Classes: Any cancellation or rescheduling of a class by the student must imperatively be done before noon the day before the scheduled class; otherwise, the class will be charged to the student.
